WE THE UNDERSIGNED DO HEREBY AGREE, WITHOUT EXCEPTION, TO THE FOLLOWING:

1. That the information presented is true.
2. That the rules and regulations have been read by the Teacher of Record, Teacher/Chaperone, Entrant and Entrant's parents and that all rules and regulations as stated or announced thereafter will be adhered to.
3. That the entrant and the teacher of record are registered for the convention.
4. That the decisions of the adjudicators are final and that all scores and tabulation sheets are the sole property of DMA.
5. If I win the title and am unable to attend the National Convention I will abdicate my title and all the benefits attached (i.e. crown, banner, scholarships, cash awards, etc.) to the first runner up.
6. I give permission as an entrant to be video taped during the competition and release DMA Florida Ch.#2 from and against any liability regarding the videotapes taken during the competition.
7. If I should win I fully understand that I must remain as a student with the DMA teacher of record or forfeit my title.

Photographs: (Not required for this competition)

Required photographs must accompany National application if you are the winner of title contest.

Two copies of the same 5 x 7 – Color Dance Pose Photograph

Two copies of the same 5 x 7 – Color Head Shot Photograph.

Photographs must be of excellent professional quality, vertical shots, and on a solid (white professional) background. Please make sure the name of the teacher and student are on the back of the photograph.

Interview:

Entrants will be required to sit before the judging panel for an interview.

Female Entrants will be required to wear a daytime dress or business type suit for the Interview portion of the Competition.

Male Entrants will be required to wear a dress shirt and tie with either, dress slacks and jacket or business type suit for the Interview portion of the Competition.

Music:

Tapes should be rewound and correctly cued. A performance CD and a CD backup are required. Please mark all CD's with name of entrant, level of competition, title of song or dance, "original" or "backup", your contestant number and teacher's name. Be sure your CD is finalized. These are to be turned in by the deadline set forth by the competition director. One penalty point will be deducted for failure to comply with these directives.

Resume:

All entrants must attach a one-page type written resume to this application. Please do not make reference to your Teacher of Record, your Teacher(s) of Recognition, your Choreographer(s) or the name of your Studio. Your resume should include your academic achievements, dance training, performances, personal achievements, special interests, school activities, hobbies, etc.

Application Deadline:

Applications must be postmarked by: February 8, 2010

A completely filled out entry form and resume' must be turned in to your teacher with payment in full. DMA Teacher will then submit entry fees to the Chapter on a Studio check made payable to **DMA Florida Chapter #2**.
